This is the first year of calculating our carbon output so there is no baseline data.

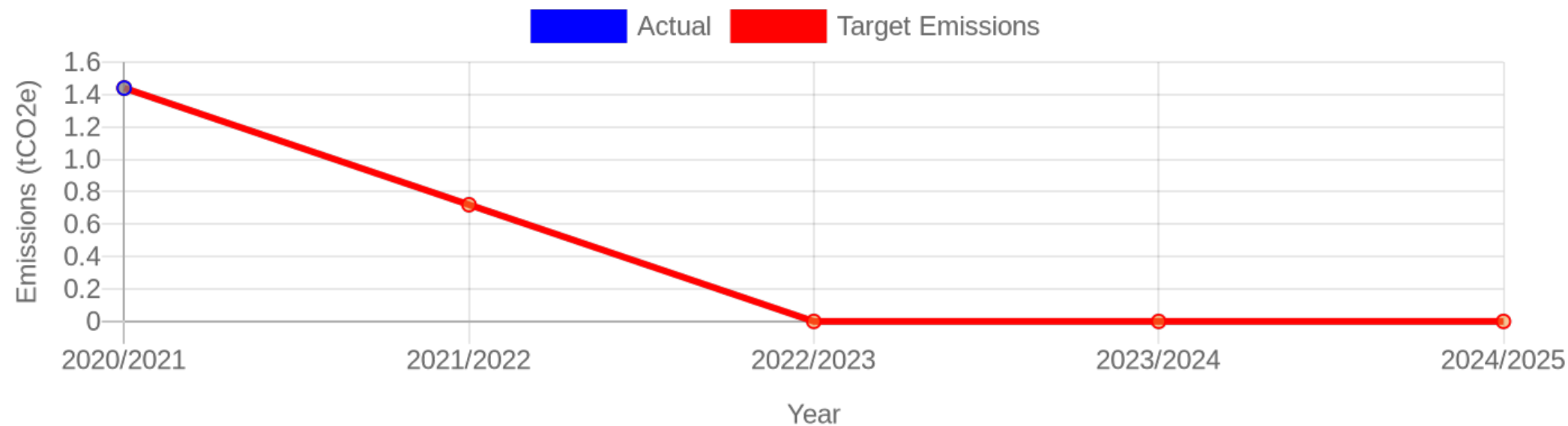

Expansion of low/zero emission vehicles amongst the company's fleet.

Review of all suppliers to identify points of environmental impact.

Only work with suppliers who have a carbon reduction strategy in place and are working towards netzero.
